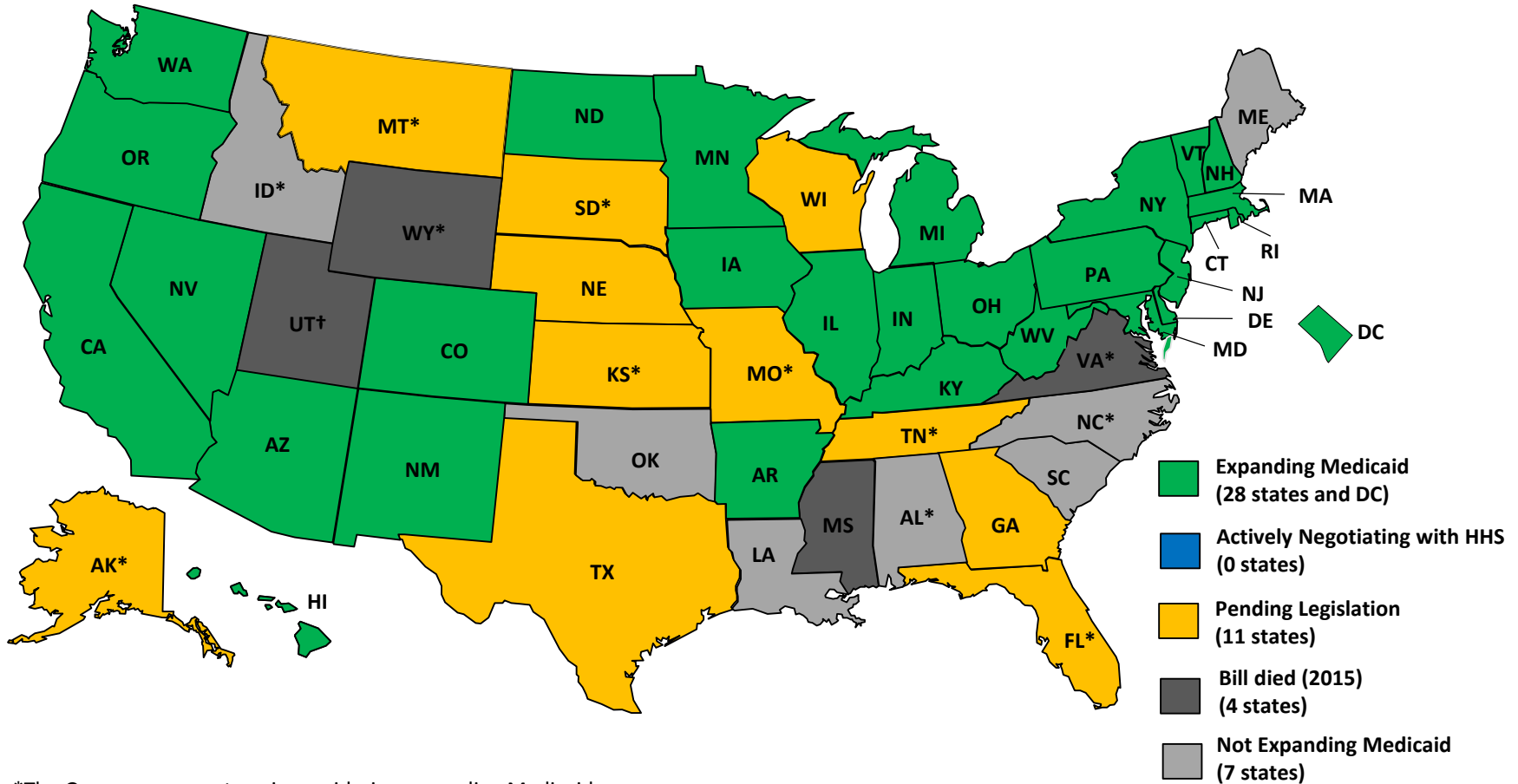


Medicaid Expansion

Current Status



*The Governor supports or is considering expanding Medicaid.

†While the Utah legislature failed to come to an agreement on Medicaid expansion during the legislative session, a committee of six, including the Governor and key members of the legislature, will work on a Medicaid expansion agreement by July 31, 2015. The Governor then intends to call a special legislative session during Summer 2015 to vote on the agreement.
